



PROSPERITY PROMOTION UPDATE

Lifemax is thrilled to announce that there are 17 distributors who have already achieved the rank of Director (Level 3) or Executive Director (Level 4). We wish to congratulate and celebrate the incredible effort put into the Prosperity Promotion by each of these Lifemax Independent Distributors! The official list of qualified distributors is available on MyLifemax.net.

To ensure we keep adding new distributors to this ever-growing list, we need to reiterate some important policies which ***MUST be strictly adhered to in order to qualify for these bonuses.***

AS STATED IN THE LIFEMAX POLICIES AND PROCEDURES

SECTION 2 – I

Each participant or legal entity is limited to 1 (one) distributorship. Spouses may each have their own distributorship with Lifemax. Spouses must be in the same line of sponsorship and a spouse may not be associated directly or indirectly with distributor positions in other downline organizations worldwide.

SECTION 2 – K

A person or entity may not apply for a distributorship worldwide using the identity of another person or entity that will not be associated with the distributorship. No one may enter a Social Security Number or Tax Identification Number that was not assigned to the primary individual or entity on the distributorship.

SECTION 4 – C

If a distributor enters multiple applications using multiple sponsors, only the first completed information to be received by Lifemax will be accepted. Lifemax reserves the right, at its sole discretion, to make the final decision with respect to all disputes. **Distributors may hold only one position in Lifemax regardless of market.**

The Prosperity Promotion was designed to encourage distributors to advance in rank and reward them financially for their efforts, and also to produce the right behavior in building their Lifemax business. To that end, existing Policies and Procedures, as mentioned above, will be strictly enforced.

AS STATED IN THE PROSPERITY PROMOTION TERMS AND CONDITIONS

Any new or existing Lifemax Independent Distributor who is found to be in violation of the Lifemax Policies and Procedures will forfeit any and all bonuses, and will be subject to termination as a Lifemax Independent Distributor. Such violations include, but are not limited to, the following:

- Having or attempting to create multiple distributorships
- Personally purchasing or knowingly recruiting someone to purchase product with the intention of rank advancement, and who, at any time during or after this promotion, returns said product for a full or partial refund.



Any refunds or charge backs that the company deems to be excessive or unusual could negate the bonus earned. Bonuses of \$10,000 and \$50,000 will be paid 60 days in arrears. No Part Two bonuses can be earned more than once during the promotion period.

The *Part One Product Activation Bonus* is open to all markets except the Philippines where an existing promotion is in place. Regarding *Part Two Rank Advancement*, for existing distributors with a baseline of Director (Level 3) or Executive Director (Level 4) to receive the \$1,000 for re-achieving their respective rank, the distributor must have fallen from that rank for a period of at least 1 month prior to re-achieving it.
